Only ENERGY STAR product models in the specific categories listed on this website are eligible for Minnesota's rebates. To determine a product model's ENERGY STAR certification, Minnesota's agents will use product information available to the public at www.energystar.gov. Qualifying appliances must be purchased and installed for resident use in Minnesota. Online purchases are not eligible. Substitutions of products or product categories are not allowed. Purchase of products that are used, rebuilt, rented, leased, exchanged, won as a prize or purchased at auction or online auction are not eligible. By applying for a rebate and subsequently failing to satisfy each of the program's requirements, an applicant gives up rights to the rebate and those rebate funds will no longer be available to him/her. Applications exceeding verifiable eligible purchases are not allowed. Applications in excess of the limits are not allowed. Rebates will be awarded on a first-come first-serve basis and are subject to available funds. OES reserves the rights to change and end any portion of this program without notice.
